Long wait ends, flyover in front of MKU ready for inauguration

THE construction of a flyover has been completed in front of the Madurai Kamaraj University and will soon be opened to the public, bringing relief for commuters on the Madurai-Kochi NH 49. The road witnesses vehicular movement round the clock and is an essential route for MKU students. Many villages are located opposite to the varsity, which adds to the traffic woes. Sources said over 100 accidents have occurred and at least 10 persons have died in the last ten years. MKU students and residents in the vicinity have been demanding the construction for a long time. The State government (NH Wing) began the project at a cost of ₹52.04 crore in 2019.

Speaking to TNIE, a highway department official said the stretch is one of the accident prone zones. "The bridge will be 1,011 metre in length with four spans, each 25 metre in length. A vehicular underpass to Vadapalanji area and MKU has been built under the bridge. The total width of the bridge is 20.20 metre. Mofussil buses coming from Madurai can directly go on the flyover and service roads are available on both sides. We are applying final touches to the bridge such as painting works, reflection lights among other things. Following documentation work, the bridge will be opened," he said.

Recalling an accident in October 2015 which killed three people, including two students and a parent, MKU Professor K Karnamaharajan

said, "Back then, MKU students had staged road-roko for several hours demanding a flyover here and after a long battle, it was heard. Those who want to go to the Vadapalanji area and railway station can take the service road on the left and MKU students and visitors can take the service road on the right side. Those who want to go to Theni can directly ply on the flyover. The underpass will also benefit the public," he added.

A resident from the locality, J Balasubramaniam welcomed the completion of the flyover and he hopes it would put an end to road accidents. "At present, Mofussil buses stop in front of Madurai Kamaraj University. A bus stop should be made available near the flyover before it is opened for use," he added.

HC closes plea against felling of palm trees

THE Madurai Bench of the Madras High Court on Thursday closed a Public Interest Litigation (PIL) petition filed against the felling of palm trees in Kadaladi taluk and neighbouring villages in Ramanathapuram, after it was informed that authorities are taking necessary action.

The litigant, S Periyasamy of R Pundunagar village in Kadaladi taluk, had submitted that there are more than 5,000 palm trees in his village that are relied upon for various purposes.

In his PIL, he alleged that anti-social elements have been felling the palm trees despite knowing its significance in the villagers' lives and had requested the court to take ac-

tion against the same. However, government counsel informed the court the local officials' findings that as many as 344 palm trees were felled by a private solar power company that bought some of the lands in the village for installing solar panels. Taking into account that the felled trees were seized by the authorities and action against the suspects are underway, the court closed the case.

Man kills alcoholic father

Madurai: A 36-year-old man was arrested by Palamedu police on Thursday for allegedly killing his father following a domestic dispute in Kodangipatti. According to police sources, the deceased, identified as K Kumar Kose (64) and his son, K Saravanakumar (36), got into an argument after Kose sought money from his son for buying alcohol. It turned fatal when Kose fainted after being kicked by his son in the stomach. Though he was rushed to the hospital, the doctors declared him brought dead. The Palamedu police registered a case and arrested Saravanakumar. ENS

32-year-old youth drowns while immersing ashes

Dindigul: A 32-year-old man from Madurai drowned while immersing ashes of a dead relative in Virupachi Thalaikuthu river near Oddanchatram in Palani. The deceased, identified as Arunprakash (32) of K.Pudur, was taking bath in the river after immersing the ashes, when he lost his balance due to the heavy currents in the river. Fire and Rescue Service personnel recovered his body and sent it for autopsy. Chathirapatti registered a case. ENS
