*** Cabinet Minister Sudhir Mungantiwar's candid speech**

Chandrapur 4 September: The issues that are under consideration in the Supreme Court have nothing to do with the stability and instability of the government in the state. This government is a stable government and it is a government of the people. The BJP has supported a Shiv Sena Chief Minister, said Cabinet Minister Sudhir Mungantiwar while interacting with reporters



on Friday. On this occasion BJP State President MLC Chandrashekhar Bawankule, MP Ashok Nete, former Union Minister Hansraj Ahir were prominently present. Cabinet Minister

Mungantiwar said, the issue of right or wrong decisions made by Chief Minister Eknath Shinde is not in the Supreme Court. The first issue is whether the notice given by the Vice President can be given if there is no confidence in the Vice President. Whatever the answer, it has to do with the stability and instability of the government. Another issue is about 48 hours notice, for what period it can be given, whether it is fair or unfair? This is the question, whatever the answer is, it has nothing to do with the stability or instability of the government. The third issue is about the chief whip, it is well known that the chief whip is not applicable to the party meeting. As there is no issue in the Supreme Court that can be used against the result, the idea of jumping to conclusion whether this government is stable or unstable is wrong, Mungantiwar said.
