No MSEDCL turnaround despite UDAY: Report

Mumbai: The compliance audit report of the Comptroller and Auditor General of India (CAG) for fiscal 2022 that was tabled in the Maharashtra Legislature on Friday said that the financial and operational turnaround of state-run power distribution firm MSEDCL was not achieved.

No security certification of MahaBT portal since 2020, says CAG report

Mumbai: The state government has not carried out the security certification of MahaBT portal since August 2020, the CAG revealed in its audit report. It was found that business rules were not properly mapped in the system, which resulted in instances where applications were processed though applicants did not upload vital documents, the report said.

Bill proposes relief for farmers hit by fake seeds

Mumbai: The state on Friday introduced a bill in the legislative assembly that aims to provide compensation to farmers for losses caused due to adulterated seeds, substandard or misbranded seeds, fertilisers or insecticides. The bill proposes to provide the payment of compensation within a month or an interest of 12% per annum in case of a delay.
