## India to take over UNSC...

Today's discussions focused on India's presidency of the Security Council, which begins on Thursday. I look forward to the month ahead."

India's 2021-2022 term on the Council ends December 31, with Kamboj, India's first woman Permanent Representative to the United Nations in New York sitting in the President's seat at the powerful horseshoe table for the month. India will also take over the year-long G20 Presidency from December 1. Countering terrorism and reformed multilateralism will be among the key priorities for India during its UNSC presidency that will culminate in the completion of its two-year tenure as non-permanent member of the 15-nation powerful body.

## Gujarat all set for today's...

The BJP and Congress are contesting in all the 89 seats. The new poll entrant AAP is contesting in 88 seats. Its candidate from Surat East constituency had withdrawn his candidature, leaving the party with one less seat to contest in the first phase.

Among other parties, the BSP has fielded 57 candidates, BTP 14 and CPI-M four candidates. As many as 339 Independents are also in the fray in the first phase of polls.

## **Ex-President Jiang Zemin...**

Jiang was on the verge of retirement as Shanghai party leader in 1989 when he was drafted by thenparamount leader leader Deng Xiaoping to pull together the party and nation. He succeeded Zhao Ziyang, who was dismissed by Deng due to his sympathy for the student-led Tiananmen Square protesters and was held under house arrest until his 2005 death.

In 13 years as party general secretary, China's most powerful post, Jiang guided the country's rise to economic power by welcoming capitalists into the ruling party and pulling in foreign investment after China joined the WTO. China passed Germany and then Japan to become the second-largest economy after the United States. Jiang captured a political prize when Beijing was picked as the site of the 2008 Summer Olympics after failing in an earlier bid.

A former soap factory manager, Jiang capped his career with the communist era's first orderly succession, handing over his post as party leader in 2002 to Hu Jintao, who also took the ceremonial title of president the following year.
