Hizbul commander among 2 terrorists killed in Poonch

Jammu: A divisional commander and veteran of terror outfit Hizbul Mujahideen (HM), Munoor Hussain, was among two terrorists killed as security forces thwarted another infiltration bid along the Line of Control (LoC) in Jammu and Kashmir's Poonch district early Monday.



Col Bartwal said, "Hussain went to Pakistan-occupied Kashmir (PoK) in 1983, came back in 1986 and again returned to PoK in 1988. He was a close associate of Maulana Dawood Kashmiri (Tehreek-ul-Jehad) who, in turn, is a close associate of Syed Salaudin (HM)," he said, adding "As per police records, Hussain's family of two wives and children are residents of Poonch."
