#### Introduction

- 1. We have reviewed the accompanying statement of unaudited consolidated financial results of L&T Finance Limited ("the Parent" or "the Company") and its subsidiaries (the Parent and its subsidiaries together referred to as "the Group") for the quarter and six months ended September 30, 2024 ("the Statement"), being submitted by the Parent pursuant to the requirements of Regulation 33 and Regulation 52(4) read with Regulation 63 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, as amended ("Listing Regulations").
- 2. This Statement, which is the responsibility of the Parent's Management and approved by the Board of Directors of the Parent, has been prepared in accordance with the recognition and measurement principles laid down in the Indian Accounting Standard ("Ind AS") 34 "Interim Financial Reporting" specified in section 133 of the Companies Act, 2013, the circulars, guidelines and directions issued by Reserve Bank of India ("RBI") from time to time ("RBI guidelines") and other accounting principles generally accepted in India and in compliance with Regulation 33 and Regulation 52(4) read with Regulation 63 of the Listing Regulations. Our responsibility is to express a conclusion on the Statement based on our review.

#### Scope of Review

3. We conducted our review of the Statement in accordance with the Standard on Review Engagements ("SRE") 2410, "Review of Interim Financial Information Performed by the Independent Auditor of the Entity" issued by the Institute of Chartered Accountants of India. This standard requires that we plan and perform the review to obtain moderate assurance as to whether the Statement is free of material misstatement. A review is limited to primarily to making inquiries of the Company personnel and analytical procedures applied to financial data and thus provides less assurance than an audit. We have not performed an audit and accordingly, we do not express an audit opinion.

We also performed procedures in accordance with the circular issued by the SEBI under Regulation 33 (8) of the Listing Regulations, to the extent applicable.

  - c. L& T Infra Investment Partners Advisory Private Limited

#### Conclusion

5. Based on our review conducted and procedures performed as stated in paragraph 3 above and based on the consideration of the review reports of the other auditors referred to in paragraph 6 and 7 below, nothing has come to our attention that causes us to believe that the accompanying Statement, prepared in accordance with the applicable lnd AS and other recognized accounting practices and policies, has not disclosed the information required to be disclosed in terms of Regulation 33 and Regulation 52(4) read with Regulation 63 of the Listing Regulations, including the manner in which it is to be disclosed, or that it contains any material misstatement or that it has not been prepared in accordance with the relevant prudential norms issued by Reserve Bank of India in respect of income recognition, asset classification, provisioning and other related matters.

#### **Other Matters**

6. We did not review the financial information of the three subsidiaries, whose unaudited financial results and other financial information reflects total revenues of Rs. 14.91 Crore and Rs. 29.26 Crore, total net profit after tax of Rs. 6.35 Crore and Rs. 12.86 Crore, total comprehensive income of Rs. 6.39 Crore and Rs. 12.86 Crore for the quarter and six months ended September 30, 2024, respectively, as considered in the Statement. These financial result / statements have been reviewed by other auditors whose reports have been furnished to us by the Management and our conclusion on the Statement, in so far as it relates to the amounts and disclosures included in respect of these subsidiaries, is based solely on the reports of the other auditors and the procedures performed by us as stated in paragraph 3 above.

Our conclusion on the Statement is not modified in respect of this matter.

7. The Statement includes the financial results of one subsidiary which has not been reviewed by their auditors, whose financial results reflects total revenue of Rs. 3.11 Crore & Rs. 3.14 Crore, total net Profit after tax of Rs. 2.33 Crore and Rs. 1.86 Crore, total comprehensive income of Rs. 2.33 Crore and Rs. 1.86 Crore for the quarter and six months ended September 30, 2024, respectively, as considered in the Statement. According to the information and explanation given to us by the Management, these financial results are not material to the Group.

Our conclusion on the Statement is not modified in respect of this matter.

- 8. The Statement includes financial figures of the Company for the quarter and six months ended September 30, 2023, which have been reviewed by the predecessor firm of statutory auditors vide its report dated October 20, 2023, in which the predecessor firm of statutory auditors has expressed unmodified conclusion.
- 9. The Statement also includes figures of the Company for the year ended March 31, 2024, audited by the predecessor firm of statutory auditors vide its report dated April 27, 2024, in which the predecessor firm of statutory auditors have expressed an unmodified opinion.

Accordingly, we do not express any conclusion on the comparative financial figures and have relied upon the said reports for the purpose of our report on this statement. Our conclusion is not modified in respect of the above matters.
